## Driverless Vehicles Introduced in Arlington Entertainment District



Next time you are in the Entertainment District for a Rangers or Cowboys game, there may be an alternative to enduring high summer temperatures as you make your way to the stadium.

On August 26, the City of Arlington debuted two air-conditioned driverless vehicles that will take fans to Globe Life Park or AT&T Stadium via trails in the Richard Greene Linear Park and Robert Cluck Linear Park. The bright red Milo shuttles, provided by Easy Mile, are free to ride and handicap accessible.

This is part of a pilot project to test the concept of low-speed driverless vehicles in Arlington. During the test, the vehicles will follow a predetermined route, using a laser on the roof to detect obstacles.

Each vehicle will have an operator on board who can override the automated setting in the case of an emergency. The vehicles, which can travel fast as 20 mph, are not permitted on the streets. For now, they will travel on the trails in the Entertainment District, comfortably providing the final connection for people trying to get from their cars to the ballgame or other nearby event.

## **Program Helps Older Adults Manage Personal Finances**

Nationwide 45% of older adults have incomes that are below 200% of the poverty level (i.e., \$24,120 per year for a single individual). For many balancing the budget can be a chore, especially when incomes are fixed and expenses are not. Further, the aging process may be accompanied by the acquisition of disabilities (e.g. low vision and cognitive impairment) and losses of life partners who'd handled finances.

To help older adults whose ability to live independently is threatened by difficulty in managing personal finances, the Aging program contracts with the Senior Source to provide money management services. The Senior Source offers bill payer services, through which clients retain control of their finances but receive assistance in developing and sticking to a monthly budget, in addition to representative payee services, through which the Senior Source is legally authorized to handle clients' Social Security checks.

The Senior Source money management program serves persons who are at least 60 years of age, have relatively limited income, and relatively limited resources. Services are available in Dallas and surrounding counties.




