  - The nominating subcommittee's recommendations regarding reappointments, new members, and RCC officers were all approved unanimously.
- 5. Conformance Review Recommendation: Permit Amendment Application, SouthWaste Disposal, LLC, Type V Facility, City of Mansfield, Texas. Jeff Mayfield, North Texas Municipal Water District and Chair of the Facility Conformance Subcommittee, will present the conformance review recommendation for RCC approval.
  - The Conformance Review Subcommittee's recommendation that this permit amendment is in conformance with the Regional Solid Waste Management Plan was

unanimously approved with two abstentions from Misty Adams, City of Arlington and Adam Hart with Republic Services.

6. Conformance Review Recommendation: Major Permit Amendment Application for the City of Arlington Landfill, Type I Facility, Tarrant County, Texas. Jeff Mayfield, North Texas Municipal Water District and Chair of the Facility Conformance Subcommittee, will present the conformance review recommendation for RCC approval.

The Conformance Review Subcommittee's recommendation that this Major Permit Amendment conforms with the Regional Solid Waste Management Plan was unanimously approved.

- **8.** Recycling Paper Cups in North Central Texas. The Foodservice Packaging Institute (FPI) will present information on the education campaign regarding the recycling of paper cups that is anticipated to launch in late 2022.

The FPI provided a presentation covering recycling paper cups. Since paper cups are considered to be contamination for many MRF's in the North Central Texas Region, a subcommittee will be formed to discuss next steps on whether or not to include paper cups in ongoing Know What To Throw activities.


