#### Item 1 Approval of Minutes

President Smith stated that the first item on the agenda was approval of the minutes from the January Board meeting.

Upon a Motion by Councilmember Gray (seconded by Judge Wood), and unanimous vote of all members present, the Board approved the minutes of the January 2017 Executive Board meeting.

### Item 16 Status Report Regarding the Economic Development District Designation for North Central Texas

President Smith announced that the Board would take this status item out of order. Lucille Johnson, Assistant to the Executive Director, introduced Jorge Ayala, Economic Development Administration (EDA) who is the Regional Director for the Austin Region, which covers five States (Texas, Louisiana, Oklahoma, Arkansas and New Mexico). He congratulated NCTCOG for obtaining designation as a Regional Economic Development District (EDD) and provided a brief introduction to this new partnership between the Region, NCTOG and the EDA. EDD Designation required the fulfillment of rigorous requirements and represents the collaborative work of the regions counties, cities, economic development corporations, workforce development boards, chambers of commerce, higher education institutions, business owners, and other stakeholders in economic development, in conjunction with NCTCOG.

### Item 2 Resolution to Accept and Approve the Comprehensive Annual Financial Report for Fiscal Year 2016

Monte Mercer, Deputy Executive Director, presented the Comprehensive Annual Financial Report (CAFR) and single audit reports for the fiscal year that ended September 30, 2016. He added that Mr. Brad Jay, Partner, Weaver and Tidwell, L.L.P., discussed the final reports with the Audit Committee. The report was free of findings or comments. He commended members of his staff, including Molly Rendon, Maggie Lira and Randy Stevenson. Councilmember Lombard remarked that the policies and procedures were very strong to result in a report free of findings. Mike Eastland congratulated Mr. Mercer and the staff for the good work.

Upon a Motion by Councilmember Lombard (seconded by Judge Self), and unanimous vote of all members present, the Board approved the resolution as presented.

# Item 3 Resolution Supporting Regional Amendments to the 2015 International Swimming Pool and Spa Code

Edith Marvin, Director of Environment and Development, asked the Board to support the promotion of building code uniformity in the North Central Texas region through Regional Amendments to the 2015 International Swimming Pool and Spa Code; and to direct staff to send the Regional Code Amendments to member cities for consideration when adopting codes. She explained that the 2015 International Codes are the most current nationally recognized industry standards for buildings and construction. The Regional Codes Coordinating Committee (RCCC) developed the regional amendments to the 2015 International Swimming Pool and Spa Code, which is a voluntary code that local governments do not have to adopt.

Upon a Motion by Councilmember Archer (seconded by Commissioner Mitchell), and unanimous vote of all members present, the Board approved the resolution as presented.

### Item 4 Resolution Authorizing Receipt of Grant Funds and Additional Staff Position to Support the Tarrant County Hazard Mitigation Action Plan (HazMAP) Update

Molly McFadden, Director of Emergency Preparedness, asked the Board to authorize one new full-time equivalent (FTE) staff position for the Emergency Preparedness Department. She explained that NCTCOG applied for grant funding under the Pre-Disaster Mitigation grant program in order to update the HazMAP for Tarrant County and its participating jurisdictions. The source of the federal portion of funds is FEMA, through the Texas Department of Emergency Management's Mitigation Section. The requested funds total \$352,000, which includes a 25% local non-federal share in the amount of \$88,000 and a 75% federal share in the amount of \$264,000. The 35 participating jurisdictions will equally share responsibility for the required match and have agreed to commit in-kind time and resources equaling 25% of total project cost. NCTCOG intends to utilize a portion of these grant funds to support an additional staff position for this initiative.

Upon a Motion by Councilmember Wilemon (seconded by Commissioner Mitchell), and unanimous vote of all members present, the Board approved the resolution as presented.

### Item 5 Resolution Authorizing the Receipt of Funds for Planning and Implementation Programs from the Texas Department of Transportation

Michael Morris, Director of Transportation, explained that NCTCOG is actively involved in the development and implementation of the State Implementation Plan for air quality because the Dallas-Fort Worth region is in nonattainment of the federal air quality standards. The Regional Transportation Council has approved Congestion Mitigation and Air Quality Improvement Program (CMAQ) funds and Surface Transportation Block Grant Program (STBGP) funds for two new projects, which total approximately \$1,530,000, as follows:

- Completion of Preliminary Engineering to design Veloweb Trail Connections in Carrollton (\$500,000 CMAQ plus \$125,000 local match from partner agencies for a total of \$625,000).
- Implementation of a Regional Aerial Photography and Data Collection Program (\$724,000 STBGP funds plus \$181,000 State match for a total of \$905,000).

Upon a Motion by Councilmember Lombard (seconded by Judge Horn), and unanimous vote of all members present, the Board approved the resolution as presented.

### Item 6 Resolution Authorizing an Agreement with the City of Dallas and Dallas County Concerning the Fiscal Year 2017 Highway Traffic Patrol Program

Michael Morris, Director of Transportation, explained that because the Dallas-Fort Worth region is in nonattainment of the federal air quality standard for ozone, the current Unified Planning Work Program provides for Congestion Management Operations, including implementation of the Texas Department of Transportation Partnership for Congestion Management such as the Dallas County Highway Traffic Program. This program is designed to rapidly clear collisions and stalled vehicles and has an estimated 2017 program cost of \$6,600,000. To address a funding shortfall, Dallas County, the City of Dallas, and the Regional Transportation Council (RTC) have developed a funding strategy in which the financial contributions from the partners include a \$3,000,000 commitment from the RTC, \$3,000,000 from Dallas County, and a \$600,000 commitment from the City of Dallas. RTC will provide \$2,400,000 in Congestion Mitigation and Air Quality Improvement Program funds with a \$600,000 state match. Any additional revenues generated from increased collection of traffic court fees and potential partnerships with tow truck operators or others will reduce each partner's contribution to the program. This program was transmitted to United States Secretary of Transportation Elaine Chao as an example of a national protocol for safety, reliability, and community policing.

Upon a Motion by Judge Horn (seconded by Councilmember Lombard), and unanimous vote of all members present, the Board approved the resolution as presented.

### Item 7 Resolution Authorizing an Agreement with the City of Fort Worth for the Citywide Active Transportation Plan

Michael Morris, Director of Transportation, explained that the Regional Transportation Council (RTC) will assist the City of Fort Worth in developing a citywide active transportation plan, in accordance with the City's Comprehensive Plan and the Complete Streets Policy. The Plan would integrate the adopted Bike Fort Worth Plan, Walk Fort Worth Plan, Master Thoroughfare Plan, and The T Master Plan to create a seamless network of on and off-street pedestrian and bicycle facilities integrated with the public transportation and thoroughfare networks. The Plan is expected to be used as a pilot for the region. Funding will include \$250,000 in RTC Local funds and \$215,000 from the City of Fort Worth.

Upon a Motion by Councilmember Gray (seconded by Mayor Strength), and unanimous vote of all members present, the Board approved the resolution as presented.

# Item 8 Resolution Approving Modifications to the FY2016 and FY2017 Unified Planning Work Program for Regional Transportation Planning (UPWP)

Dan Kessler, Assistant Director of Transportation, presented the proposed modifications to the FY2016 and FY2017 UPWP, which identifies the activities to be carried out between October 1, 2015, and September 30, 2017. He explained that the modification included new initiatives, a funding adjustment, and text updates to clarify project funding sources. The Regional Transportation Council approved the modifications at its February 9, 2017 meeting. Federal law (Fixing America's Surface Transportation (FAST) Act) assigns the MPO responsibility for carrying out the metropolitan planning process and for development of a UPWP that addresses the planning priorities of the metropolitan area, the metropolitan transportation and related air quality planning activities to be undertaken and the capital purchases needed to support the planning process.

Upon a Motion by Councilmember Lombard (seconded by Councilmember Archer), and unanimous vote of all members present, the Board approved the resolution as presented.

#### Item 9 Resolution Authorizing the Transfer of Transit Buses to Ozark Regional Transit

Michael Morris, Director of Transportation, explained that in January 2017, Ozark Regional Transit (ORT) in Springdale, Arkansas experienced a fire that destroyed a majority of their fleet. NCTCOG is in possession of three non-Americans with Disabilities Act (ADA) accessible buses acquired in late 2015 when Texoma Area Paratransit System (TAPS) discontinued providing public transportation services. There has been no interest from small transit providers or transit authorities in the region or state who would be able to use them, since these vehicles do not comply with requirements in the urban portions of the region. ORT has confirmed that they are able to utilize the vehicles as soon as possible. The Texas Department of Transportation (TxDOT) Public Transportation Division and the FTA Region 6 Office have expressed support of this transfer effort and are working concurrently with staff to expedite the necessary approvals.

Upon a Motion by Councilmember Archer (seconded by Judge Wood), and unanimous vote of all members present, the Board approved the resolution as presented.

### Item 10 Resolution Accepting the Audit Report from Weaver and Tidwell, LLP, for Agreed Upon Procedures

Michael Morris, Director of Transportation, explained that the accounting firm of Weaver and Tidwell, LLP, conducted an external audit of Transportation Department consultant and subgrantee contracts that closed during Fiscal Years 2014 and 2015 and were in excess of \$250,000. This review is a requirement of the Metropolitan Planning Organization's procurement policies under agreement with the Texas Department of Transportation. The audit consisted of a financial and non-financial review of Transportation Department consultant and subgrantee contracts to verify the Agency's adherence with invoice and contract compliance procedures. The report concluded that there were no exceptions in any of the above procedural areas for the contracts reviewed.

Upon a Motion by Councilmember Lombard (seconded by Councilmember Archer), and unanimous vote of all members present, the Board approve the resolution as presented.

### Item 11 Resolution Appointing a Legislator as an Ex-Officio Member of the North Central Texas Council of Governments' Executive Board

Mike Eastland, Executive Director, explained that House Bill 2160 (82nd Session) requires each Council of Governments to offer an ex-officio, non-voting seat on their Executive Board to a member of the legislature whose district is located wholly or partly within their region. The NCTCOG Executive Board previously adopted a resolution specifying the process for choosing a legislator to fill this seat. In accordance with the Board's process, letters were sent to each of the eligible legislators. The letter asked them to acknowledge their interest in holding the seat, with the understanding that a lottery would be conducted to assure an impartial selection. Five Legislators expressed an interest in holding the seat. Mike Eastland asked Dan McClendon, Mayor Pro Tem of the City of Burleson, to draw from among five numbers representing the five legislators. The number representing Representative Ron Simmons was chosen in the lottery and the Board appointed him, by resolution, to hold the seat through January 31, 2019.

Upon a Motion by Councilmember Archer (seconded by Commissioner Mitchell), and unanimous vote of all members present, the Board approved the resolution as presented.

#### Item 17 Status Report on The Big-X, North Central Texas Full-Scale Exercise Completion

Molly McFadden, Director of Emergency Preparedness, briefed the Board on the Big-X Regional Full-Scale Exercise. The Big-X was a three-day exercise that took place on November 11-13, 2016. It included exercise play for 13 emergency response disciplines that encompassed 41 scenarios at 36 locations with over 1,500 total participants. Big-X 2016 officially concluded on January 25, 2017, with the After Action Report and Improvement Plan (AAR/IP) Conference. This conference brought all exercise planners and participating disciplines back

together to discuss the identified strengths and areas for improvement found during exercise conduct. The final Big-X AAR/IP was published on January 31, 2017 and the region will use this information to identify gaps and areas for improvement, to develop needed training, and as the basis for procuring equipment needed to fill gaps.

# Item 18 Status Report on Emergency Management Working Group (EMWG) Upcoming SHSP Grant Projects

Molly McFadden, Director of Emergency Preparedness, briefed the Board on two EMWG State Homeland Security Program Grant Program (SHSP) projects. The second phase and final project of the FY15 Emergency Operation Center (EOC) SHSP grant supports a regional response team of professional emergency managers that can quickly mobilize to support jurisdictions in the North Central Texas region during disasters. The FY16 EOC SHSP grant will organize and conduct a regional response summit. The summit will assemble personnel from various functional and/or discipline-specific response teams. These teams will educate other regional response teams and groups on available mutual aid response assets and resources in the public, private and non-profit sectors.

SUBJECT: Resolution Authorizing a Contract with SHI Government Solutions, Inc. to

Provide Online Learning Content to the Region

In January 2016, the North Central Texas Council of Governments (NCTCOG) secured Cornerstone OnDemand, a learning and development system, and made it available through North Texas SHARE and the Training and Development Institute (TDI), providing time and cost savings to participating entities in the region by leveraging a shared technology platform. As part of this initiative, staff has an immediate need to offer online learning content to early program participants.

Online learning content products are available utilizing a State of Texas Department of Information Resources (DIR) contract with SHI Government Solutions, Inc. Due to the volume of requests from program participants and interested parties, NCTCOG intends to conduct a competitive procurement to secure long-term online learning content providers in an effort to offer choices to program participants. This contract with SHI Government Solutions, Inc. is to be used on an interim basis until final content providers are selected and awarded contracts by NCTCOG.

Due to the shared nature of this program and the shared technology platform, NCTCOG serves as the conduit for payment between SHI Government Solutions, Inc. and participating entities. All costs incurred under this contract are reimbursed to NCTCOG from the participating entities.

A draft resolution authorizing a contract with SHI Government Solutions, Inc., for online learning content and related services, in an amount not to exceed \$150,000 is attached for Executive Board consideration. I will provide a brief presentation and be available to answer any questions prior to requesting Board approval.

# RESOLUTION AUTHORIZING A CONTRACT WITH SHI GOVERNMENT SOLUTIONS, INC. TO PROVIDE ONLINE LEARNING CONTENT TO THE REGION

**WHEREAS**, the North Central Texas Council of Governments (NCTCOG) is a Texas political subdivision and non-profit corporation organized and operating under Texas Local Government Code Chapter 391 as the regional planning commission for the 16-county North Central Texas region; and,

**WHEREAS**, NCTCOG is a voluntary association of, by and for local governments established to assist in planning for common needs, cooperating for mutual benefit, and coordinating for sound regional development; and,

**WHEREAS**, NCTCOG has identified an interim need for online learning content to offer North Texas SHARE and Training and Development Institute (TDI) participants; and,

**WHEREAS**, NCTCOG, as a political subdivision of the State of Texas, is eligible to purchase goods and services through State of Texas Department of Information Resources (DIR) cooperative purchasing contracts; and,

Due to the shared nature of this program and the shared technology platform, NCTCOG serves as the conduit for payment between the Cornerstone OnDemand and participating entities. All costs incurred under this contract are reimbursed to the NCTCOG from the participating entities.

SUBJECT: Resolutions Authorizing Grant Applications to the Department of Energy

The US Department of Energy (DOE) released the Fiscal Year 2017 Vehicle Technologies Deployment Funding Opportunity Announcement to provide funding for projects that accelerate the deployment and adoption of sustainable transportation technologies, including market-ready vehicles and alternative fuels. Area of Interest 1 seeks to accomplish this through community-based partnerships among State and local governments and the private sector. Area of Interest 2 focuses on "living laboratory" projects that promote energy efficient mobility systems. The grant submittal deadline is March 24, 2017.

North Central Texas Council of Governments (NCTCOG) staff proposes to submit a grant application under Area of Interest 1. The proposed project expands the use of electric vehicles (EVs) through campus-based car sharing initiatives. This application will be submitted on behalf of a team of DOE-designated Clean Cities Coalitions, including Dallas-Fort Worth Clean Cities (DFWCC), and colleges and universities located in each participating Clean Cities region. NCTCOG will serve as the prime recipient. If awarded, NCTCOG will receive up to \$5,000,000 federal DOE funds. The application could be lower, at approximately \$3,000,000 federal DOE funds. Matching funds are required in an amount equal to or greater than the federal funds requested. Match is expected to be met through the value of vehicles, equipment, other resources, and contributions from industry and other project partners. In addition, staff will seek a commitment of \$50,000 in local funds from the Regional Transportation Council to support project start-up costs.

In its capacity as DFWCC, NCTCOG was also invited to participate in a project proposed under Area of Interest 2 by the New York State Energy Research and Development Authority (NYSERDA). This project would increase use of EVs through car sharing programs based at multifamily residential developments in three regions, including North Central Texas. If awarded, NYSERDA would provide federal funds to support NCTCOG staff efforts to perform local outreach and awareness activities about the project, and assist with data analysis. NCTCOG is not required to provide any matching funds.

The multi-region nature of these proposals builds on success NCTCOG has recently seen in working collaboratively with other regions in the country, beginning with participation in the Solar Ready II project led by the Mid-America Regional Council. Such partnerships have led to additional funding opportunities and invitations to participate in more multi-region projects as federal agencies have narrowed focus to larger, more strategic partnership-based projects. It should be noted that because the two projects fall into two separate Areas of Interest, they will not compete against one another.

Proposed work performed under these grants supports Subtasks 3.03 and 3.04 of the Unified Planning Work Program for Regional Transportation Planning, and is consistent with the role NCTCOG serves as a local Clean Cities Coalition. Moreover, these projects expand use of zero-emission vehicles in the North Central Texas region, aiding efforts to reduce ozone-forming emissions and attain the ozone standard.

Draft resolutions authorizing submittal of grant applications to the Department of Energy for these projects are attached for Executive Board consideration. I will provide a brief presentation on this item and be available to answer any questions prior to requesting Board approval.

the Transit Related Improvement Program Funding Partnership

On March 9, 2017, the Regional Transportation Council (RTC) approved a funding partnership to assist the Dallas Area Rapid Transit with its Transit Related Improvement Program (TRIP). As part of the partnership, DART will be providing \$20 million in local funds to the North Central Texas Council of Governments (NCTCOG) as the RTC's fiduciary agent for RTC-related programs. This funding partnership is similar to those approved by the RTC in 2005 with Denton County and the City of Dallas to create a pool of RTC/Local funds.

In December 2016, DART staff requested assistance to develop a partnership that helps it respond to concerns from member cities without rail service. The proposed partnership helps DART and benefits the region by increasing the pool of RTC/Local funds. In January 2017, the DART Board approved the TRIP policy for DART cities without rail service in operation or rail service within an approved financial plan. The program encourages eligible cities to submit appropriate transportation projects for reimbursement from DART.

DART requested a partnership with the RTC over eight years to assist in the TRIP. As part of the partnership, DART and the RTC will each contribute half the funds for TRIP in two increments. The RTC will contribute an additional \$10 million federal in each phase in return for \$10 million in local funds (\$20 million total) to be provided by DART for RTC-related programs. DART will transfer funds in Fiscal Years 2018 and 2021, upon receipt of the corresponding federal funds. The local funds would increase the region's RTC/Local pool.

A draft resolution is attached for Executive Board consideration which authorizes an agreement with the Dallas Area Rapid Transit to receive \$20 million in local funds pursuant to the Transit Related Improvement Program Funding Partnership approved by the RTC. I will provide a brief presentation on this item and be available to answer any questions prior to requesting Board approval.

SUBJECT: Status Report on Countywide Watershed Management Roundtable

The North Central Texas Council of Governments (NCTCOG) has learned, through discussions with some of our county member governments, that there are efforts currently underway to update watershed management practices, in some cases as a response to past flooding and water quality issues and in others to address future growth. We have understood that there would be a benefit to our members to gain an understanding of the current variety of approaches towards watershed management practices utilized throughout our region. In response, NCTCOG conducted a survey as well as hosted a Countywide Watershed Management Roundtable on March 14, 2017. The purpose of this roundtable was: to share knowledge of the various county watershed regulations currently practiced within our region; to share knowledge of what is allowable for counties under current legislation; to enable peer discussion and explore ideas of what standards would be regionally beneficial and desirable if consistency could be created; and where resources are limited, to explore the tools that could be utilized to achieve implementation of those standards.

In order to support our member governments in working towards creation of a preferred regional consistency, and to recognize the cost savings associated with the investment in effective watershed management to reduce or prevent flooding, slow water quality decline, and avoid loss of opportunity that is a result of rapid growth, NCTCOG has begun creating a document that captures the feedback that we received from our member counties at our Roundtable. We will be providing a draft resolution that lists these desired standards as a menu of options to be chosen from and adopted by our county governing bodies.

This draft resolution will be presented for our Executive Board consideration in April for regional support and direction to distribute to our county governments these desired standards as well as the enabling legislation materials, through a presentation at a summit of our judges and district attorneys in the early summer timeframe.

SUBJECT: Status Report on the Upcoming Regional Response Summit

Follow up from January 2017 Status Report on Emergency Management Working Group (EMWG) Upcoming SHSP Grant Projects

We encourage you to save the date for the Regional Response Summit on July 19 & 20 at the Ruthe Jackson Center in Grand Prairie, TX. The regional response summit is a project of the Emergency Management Working Group and will assemble personnel from various functional and/or discipline-specific response teams to provide awareness, education, networking, and collaboration opportunities. The purpose of this project is to enhance the NCT response mission areas by educating regional response teams and groups on available mutual aid response assets, as well as resources in the public, private and non-profit sectors. A formal save the date will be e-mailed to you after the meeting.

The recent Big X Regional Response Exercise After Actions Report and Improvement Plan (AAR/IP) identified the need for the NCT area to increase integrated response efforts and education. Additionally, the NCT THIRA identified integrated efforts of both public and private stakeholders as a capability target for response efforts under Operational Coordination. The THIRA also identifies the core capability of Public and Private Services and Resources and the use of governmental, nongovernmental and private-sector resources in the initial response phase of an incident. The regional response summit will directly support these gaps from the AAR/IP and THIRA by providing a platform to inform and educate all specialized teams, emergency managers, and responders on what the region's capabilities are which will directly facilitate integration and collaboration of the region's response elements.
