
Materials Management Solid Waste Grant Briefing Sessions

The Public Works Construction Standards represents over 40 years of regional cooperation and coordination between local government and private industry public works professionals in the North Central Texas region. The November 2017 Public Works Construction Standards North Central Texas, Fifth Edition represents the culmination of an intensive comprehensive review and refinement process to update the 2004 Fourth Edition Standard Specifications for Public Works Construction and also includes the 2004 Second Edition of the Standard Drawings for Public Works Construction. The update is the result of feedback from NCTCOG's local government members and the engineering, supplier, and construction industries that confirmed the wide use of the document in North Central Texas. Additionally, regional input indicated that an update to the 2004 Fourth Edition was needed to address new technologies, materials, and methods now common in the industry and practice in North Central Texas.

Deadlines for TERP Grants Approaching



Entities considering applying for two types of grants offered through the Texas

Commission on Environmental Quality's Texas Emissions Reduction Program should act fast. The deadlines for both are approaching early in the new year.

The **Alternative Fueling Facilities Program (AFFP)** offers grants for construction or expansion of alternative fuel fueling stations within the Clean Transportation Zone, which includes the 12-county metropolitan planning area. The Application deadline is January 16, 2018.

Rebate Grants is a simplified first-come, first-served program offering grants for the repower or replacement of diesel heavy-duty vehicles and non-road equipment. The application deadline is February 13, 2018.

An opportunity through the **Texas Natural Gas Vehicle Grant Program**, which offers grants for the repower or replacement of medium- or heavy-duty vehicles with natural gas or propane, is coming soon. Aging Workshops Help Participants Deal with Chronic Pain

According to the National Institute on Health, more than one in ten Americans deals with chronic pain, defined as being present every day for three months or longer. Left unchecked, it can have a deleterious effect on mood, energy, mental and physical performance.

NCTCOG's Aging program is launching a program that helps those affected by chronic pain better manage the condition. Using a curriculum developed by Stanford University, its master trainers and lay leaders are conducting a series of six consecutive workshops for small groups of older adults who contend with pain on a daily basis. Workshops meet once a week and support participants in developing the skills needed in the day-to-day management of chronic pain in order to maintain and/or increase life's activities. They also teach coping strategies to help participants to manage chronic pain, medications, and increase physical activity levels.
