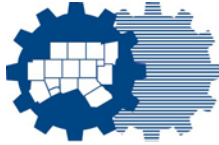
- Carolyn presented slides on Cost Share commitments.

- Illicit Discharge Detection & Elimination Roundtable
  - Upcoming Meeting March 31<sup>st</sup> at 9:30 AM. We are looking for case studies for this meeting. At the meeting, we will also be discussing our basic dry weather training and an industrial inspector's workshop for FY22.
  - We have set a date for the Basic Dry Weather Training of Thursday May 5, to be hosted at the City of Irving's Facilities. We have some volunteers already, but we are still looking for help in running the training, specifically from a phase I city.

- Stormwater Monitoring Program
  - The Stormwater Monitoring Program is in the 5<sup>th</sup> and final year of the permit term.
  - Right now, we are finalizing the 2021 Stormwater Monitoring Annual Report for submission to TCEQ ahead of the March 1<sup>st</sup>, 2022, deadline.
  - Alongside the report, we are also conducting a Best Management Practices Analysis and Evaluation plan (BANEP). We recently set a deadline for our participants to submit their BANEP data and an associated constraints form by April 15, 2022.

- Integrated Stormwater Management (iSWM) Program Activities
  - Upcoming meeting on March 30<sup>th</sup> at 1:30 pm via Microsoft Teams. At the meeting, we will be discussing our tasks related to Task Order 6.
  - We have requested feedback on a few items – Updated Site Development Control documents, Drafts of the Economic Benefits of iSWM handouts, and a final review of the Hydrologic Mimicry Research document.   - The City of Arlington has recently submitted an iSWM implementation application. We are currently conducting the review process of their application. We should know the outcome of that review in the coming months.

Sending a shout out to Frisco for allowing the new Plano staff to shadow their team to learn. Would like to know how the rest of the committee feel about having an in-person meeting.

Krista Pender, City of Carrollton – has had some revisions requested. They have a creek cleanup on March 5<sup>th</sup> to kick off next challenge. Would like at least one meeting in person.

Perry Harts, City of Frisco – At least one meeting in person per year, maybe warming weather. 3<sup>rd</sup> year in reporting on stormwater plan, has not been approved yet. Thinks it makes more sense to spend more on education/training for next years budget.

Greg Dickens, City of Hurst – Maybe 1 in person meeting per year would be good.

Howard Redfearn, City of Mansfield – Holdup on phase 2 swmp approvals has been some sort of negotiation with EPA, per communication with Rebecca at TCEQ. That is supposed to have been worked out and hopefully get approval for SWMPS. Is on year 4 of SWMP that is not approved yet. Earth Day Mansfield event is taking place this year, cancelled last two years due to covid restrictions.

Tracy Homfeld, Collin County – No updates but would like to have an in person meeting.

Rick Shaffer, City of Weatherford – In favor of in person meetings. Rick Shaffer introduced Chad Marbut and Bill Smith.

Mitchell Carpenter, Tarrant County - they have filled Robert Berndt's position (Maria Moreno).

James House, Town of Prosper – had a question on using building inspectors enforcing stormwater issues on new lots.

City of Lewisville – Working on Annual Report and still waiting on TCEQ to send notice to publish for SWMP. Castle Hills annexation has been a challenge.
