Public Comment on Agenda Items

The public telephone line was unmuted at 1:09 pm, and members of the public were invited to comment on any item on the agenda. Peter James, General Manager from Crystal Clear Automation, LLC, asked to speak to the Board regarding Item #7 and stated that he did not believe that Lea+Elliott was the most qualified firm to develop performance guidelines for an automated transportation system. Michael Morris, Director of Transportation, responded that a committee made up of non-Cog and Cog Transportation officials had scored the firms that had submitted proposals and Lea+Elliott was deemed to be the best suited to perform the expected deliverables specified in the Request for Proposals. Judge Sweet thanked Mr. James for his comments.

ACTION:

Item 1 Approval of Minutes

Judge Sweet stated that the first item on the agenda was approval of the minutes from the March Board meeting.

Upon a Motion by Mayor Carmona (seconded by Commissioner Mitchell), and unanimous vote of all members present, the Board approved the minutes of the March Executive Board meeting.

Mayor Dana-Bashian joined the meeting.

Item 2 Resolution to Accept and Approve the Quarterly Investment Report

Molly Rendon, Director of Administration, presented the Quarterly Investment Report for Board acceptance and approval and showing the investment activity for the quarter that ended March 31, 2021. She explained that the report is required by the Investment Policy and complies with the Public Funds Investment Act. She also provided a supplementary schedule showing the State's investment activity for Regional Toll Revenue funds as well as the NTTA Hwy 161 funds.

Upon a Motion by Mayor Dana-Bashian (seconded by Mayor Pro Tem Prince), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 3 Resolution Authorizing Alzheimer's Disease Programs Initiative Grant Application to the Administration for Community Living

Doni Green, Director of Aging, asked the Board to authorize the submittal of a grant application to the Administration for Community Living under the Alzheimer's Disease Programs Initiatives (ADPI) in the amount of \$1 million, with a required 25% match generated through cash and in-kind contributions. She explained that this funding is available to states and community-based organizations to strengthen supports for persons with dementia and their family caregivers and would benefit the 16-county service area and an additional 14 counties in East Texas. Innovative programs would identify those who live alone or have intellectual and developmental disabilities and are at risk of developing dementia, connect them with community-based services and provide expert consultation to their families. NCTCOG would execute performance-based contracts with the Alzheimer's Association, Dementia Friendly Fort Worth, Dementia Friendly Denton, the Alzheimer's Alliance of Smith County, the University of North Texas Health Science Center, Parkland Health and Hospital System, Meals on Wheels of Tarrant County, Baylor Scott and White, the James L. West Center for Dementia Care, the Maurice Barnett Geriatric Wellness Center, Tarrant County MHMR, the Community for Permanent Supported Housing, Stepping Stones, and Ardent Spirit.

Upon a Motion by Judge Clark (seconded by Judge Sweet), and unanimous vote of all members present, except for Mayor Pro Tem Prince who abstained, the Board approved the resolution as presented.

Item 4 Resolution Endorsing Grant Application Submittal to the Texas Water Development Board for the Integrated Watershed Based Planning for Regional Transportation and Stormwater Management in the Upper Trinity River Basin

Edith Marvin, Director of Environment and Development, asked the Board to authorize the submittal of a grant application in the amount of \$3,000,000 to the Texas Water Development Board (TWDB) for Flood Infrastructure Fund Category 1 - Flood Protection Planning for Watersheds. The Flood Infrastructure Funds (FIF) will be matched with Surface Transportation Block Grant funds awarded by the Regional Transportation Council, as required for the fifty percent match, for a total project cost of \$6 million. She explained the Integrated Transportation and Stormwater Management Project proactively engages communities in comprehensive planning efforts that integrate transportation, environmental, and stormwater needs in order to address the health, safety, and welfare concerns of the region while helping local governments manage their growth and development in a cost-effective manner.

Upon a Motion by Councilmember Allen-Gray (seconded by Mayor Heidemann), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 5 Resolution Endorsing Grant Application to the Federal Transit Administration for the 2021 Low or No Emissions Grant Program

Michael Morris, Director of Transportation, requested endorsement of grant applications in the amount of approximately \$8 million of federal funds, which includes an amount not to exceed \$7.7 million of FTA funds and \$1.6 million of Regional Transportation Development Credits to serve as local match, and previously

approved by the Regional Transportation Council. He explained the funding would implement a project electrifying the Trinity Railway Express (TRE) Link shuttle service, which provides travelers a connection between the CentrePort TRE station to Dallas-Fort Worth International Airport. The scope of the project includes purchase of battery powered electric buses and associated supporting infrastructure. This project further supports efforts to attain the federal ozone standard and improve efficiency in the transit system.

Upon a Motion by Mayor Carmona (seconded by Councilmember Ryan), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 6 Resolution Authorizing a Contract with BKD, LLP for Professional Services to Support Transit Accounting Models for Transit Agencies

Michael Morris, Director of Transportation, requested approval of a contract between NCTCOG and BKD, LLP in an amount not to exceed \$250,000. He explained that the project is to be funded through Federal Transit Administration (FTA) funds and utilizing Transportation Development Credits (TDCs) in lieu of a local match. BKD will evaluate transit agencies' accounting models, establish allocation methodologies and provide staff training to ensure the transit agencies meet federal and state requirements. He also stated that BKD has committed to meet a minimum Disadvantaged Business Enterprise (DBE) participation goal of 7.5 percent, which exceeds the published goal of 4.9 percent.

Upon a Motion by Mayor Carmona (seconded by Judge Campos), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 7 Resolution Authorizing a Contract with Lea+Elliott, Inc. to Develop Performance Guidelines for an Automated Transportation System

Michael Morris, Director of Transportation, asked the Board to approve a consultant contract with Lea+Elliott, Inc. to develop performance guidelines for an automated transportation system to support freight and peoplemovement environments. The focus of the performance guidelines is to shape future engineering procurements for real-world freight and people-movement projects. Mr. Morris explained that the consultant contract will not exceed \$850,000 and will be funded with Surface Transportation Block Grant (STBG) Program funds and 170,000 Regional Transportation Development Credits in lieu of local match, He also stated that Lea+Elliott committed to a minimum of 34% Disadvantaged Business Enterprise (DBE) participation goal.

Item 8 Appointments to the North Central Texas Economic Development District Board

Lucille Johnson, Assistant to the Executive Director, asked the Board to appoint three new members to the North Central Texas Economic Development District (NCTEDD) Board, to serve a three-year term and fill vacant seats two representatives in the Principal Economic Interest Category, and one representative in the cities with populations less than 25,000 category. She explained the two representatives in the Principal Economic Interest Category are Dr. Maria Martinez-Cosio, Interim Dean and Full Professor for the College of Architecture, Planning and Public Affairs (CAPPA) at the University of Texas at Arlington, and Leah Clark, Executive Director for the Bridgeport Economic Development Corporation (EDC). She stated Dr. Martinez-Cosio has been at UTA for more than 17 years, and Ms. Clark has been with the Bridgeport EDC since September 2016. Additionally, she requested an appointment for Jim Wehmeier, Economic Development Director for the City of Ennis, representing in the cities less than 25,000 population category, who brings 15 years of experience.

- Item Title: Resolution Authorizing the Receipt of Federal Transit Administration American Rescue Plan Funding Allocations in Response to the Coronavirus (COVID-19)

The US Department of Transportation's Federal Transit Administration (FTA) announced April 2, 2021, approximately \$30.5 billion in federal funding nationwide to help public transportation systems respond to the Coronavirus (COVID-19). Funding is provided through the American Rescue Plan (ARP) Act of 2021. The North Central Texas Council of Governments (NCTCOG) is the designated recipient for the Dallas-Fort Worth-Arlington (DFWA) Urbanized Area (UZA).

The DFWA UZA will receive \$340,487,932 to support operations, payroll, and other expenses generally eligible under the Urbanized Area Formula Program for four transportation providers. The Denton-Lewisville (DL) UZA will receive \$14,115,131 to support these same eligible expenses for one transportation provider. While FTA funds are typically included in the Transportation Improvement Program and follow that approval process, the FTA waived those requirements for these funds in order to expedite the receipt of funds. The Regional Transportation Council approved the funding allocations on May 13, 2021.

A portion of these funds will be available for the North Central Texas Council of Governments to pass through to two small public transit providers: Public Transit Services (PTS), which provides service in Palo Pinto and Parker Counties, and STAR Transit, which serves Kaufman and Rockwall Counties and a portion of Dallas County. All other entities will receive their funds directly from the FTA. Federal funding available through the ARP Act will be provided at a 100 percent federal share with no local match required. NCTCOG will enter into a grant agreement with FTA for approximately \$635,549 of the DFWA allocation, which will be passed through to PTS and STAR Transit to prevent, prepare for, and respond to COVID-19.

A draft resolution authorizing receipt of these funds and the execution of necessary agreements with PTS and STAR Transit is attached for Executive Board consideration. I will provide a brief presentation on this item and will be available to answer any questions prior to requesting Board approval.

RESOLUTION AUTHORIZING THE RECEIPT OF FEDERAL TRANSIT ADMINISTRATION AMERICAN RESCUE PLAN FUNDING ALLOCATIONS IN RESPONSE TO THE CORONAVIRUS (COVID-19)

WHEREAS, the North Central Texas Council of Governments (NCTCOG) is a Texas political subdivision and non-profit corporation organized and operating under Texas Local Government Code Chapter 391 as the regional planning commission for the 16-county North Central Texas region; and,

WHEREAS, NCTCOG is a voluntary association of, by and for local governments established to assist in planning for common needs, cooperating for mutual benefit, and coordinating for sound regional development; and,

WHEREAS, NCTCOG has been designated as the Metropolitan Planning Organization (MPO) for the Dallas-Fort Worth Metropolitan Area by the Governor of the State of Texas in accordance with federal law; and,

WHEREAS, the Regional Transportation Council (RTC), comprised primarily of local elected officials, is the regional transportation policy body associated with NCTCOG, and has been and continues to be a forum for cooperative decisions on transportation; and,

WHEREAS, NCTCOG is a Designated Recipient of Federal Transit Administration (FTA) Urbanized Area Formula Program, Enhanced Mobility of Seniors and Individuals with Disabilities Program funds in the Dallas-Fort Worth-Arlington and Denton-Lewisville Urbanized Areas, as delegated by the Governor of the State of Texas; and,

WHEREAS, Subtask 3.05 of the Fiscal year (FY) 2020 and FY 2021 Unified Planning Work Program provides for NCTCOG to serve as the federal grantee for local public transit providers operating service in the Dallas-Fort Worth-Arlington and Denton-Lewisville Urbanized Areas, with responsibilities of administration, grant management and compliance for FTA formula programs; and,

WHEREAS, on May 13, 2021, the RTC approved the US Department of Transportation's Federal Transit Administration funding allocations in response to the Coronavirus (COVID-19) provided through the American Rescue Plan (ARP) Act for public transit providers operating service in the Dallas-Fort Worth-Arlington and Denton-Lewisville Urbanized Areas for implementation of transit projects through coordination with NCTCOG, as the federal grantee; and,

WHEREAS, federal funding available under the ARP Act will be provided at a 100 percent federal share with no local match required to entities receiving funding.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT:

- **Section 1.** The North Central Texas Council of Governments is authorized to submit grant applications to receive approximately \$635,549 in ARP Act funds and administer the program consistent with State and federal regulations.
- **Section 2.** These funds and projects will be incorporated into the applicable fiscal year budgets and Unified Planning Work Program (UPWP) as appropriate.

- **Section 3.** Agreements or Amendments between NCTCOG and subrecipients in the amount of federal funds, outlined in Attachment 1, be and are hereby approved.
- <u>Section 4.</u> The Executive Director or designee is authorized to execute necessary agreements in the name of the North Central Texas Council of Governments to carry out the initiatives described herein.
- **Section 5.** This resolution shall be in effect immediately upon its adoption.

- Item Title: Resolution Authorizing Purchase and Placement of Education Campaigns for Transportation Initiatives: Phase 3

Since January 2014, the Executive Board has approved education campaign funding annually for various transportation programs, but this year we are bringing you these campaigns in phases so that we can be strategic in how we plan and implement our messages, and we will come back to the Executive Board at future meetings with another phase or phases. Fiscal Year (FY) 2021 Education Campaigns for Transportation Initiatives: Phase 1 was brought before the Executive Board and approved in October 2020 and Phase 2 was approved in February 2021. FY2021 Education Campaigns for Transportation Initiatives: Phase 3 is ready to move forward and was included in the FY2020 and FY2021 Unified Planning Work Program (UPWP), which was approved by the Regional Transportation Council (RTC) and Executive Board.

Combining education campaign efforts within the Transportation Department has resulted in increased website traffic, greater public participation, and lower costs. Additional benefits received include efficiencies with media outlets such as improved staff coordination, increased timeliness, a broader audience reach, including historically underserved populations, and cross program communication. Education campaigns may be presented through print publications and digital placements, radio and TV spots, billboards, social media, transit, and other transportation displays in multiple languages when appropriate. Phase 3 will support the activities listed below:

The Ozone Season Emissions Reduction Campaign promotes transportation-related clean air strategies and activities in the Dallas-Fort Worth nonattainment area. Air North Texas is the ozone season emission reduction campaign and partnership that promotes a consistent and comprehensive message about the importance of clean air and is a resource for clean air issues. It is funded with \$205,000 in Congestion Mitigation and Air Quality Improvement (CMAQ) funds and Regional Transportation Council (RTC) Transportation Development Credits (TDCs) in lieu of cash match.

The Regional Smoking Vehicle Program is designed to inform vehicle owners their vehicle may be creating excessive smoke and emitting pollutants, which are harmful to our health and environment, and on ways to fix their vehicle. This effort is funded with \$10,500 in Surface Transportation Block Grant Program (STBG) funds and RTC TDCs in lieu of cash match.

The Transit Pandemic Recovery Program promotes transit options through local influencers by promoting how much Dallas Area Rapid Transit, Denton County Transportation Authority, and Trinity Metro are doing to keep riders safe and healthy and that transit is here for North Texans to get them where they need to go. This effort is funded with \$100,000 of CMAQ funds and RTC TDCs in lieu of cash match.

The Saving Money and Reducing Truck Emissions Program aims to provide outreach to heavyduty fleets on strategies focused on reducing emissions from these vehicles by encouraging improving efficiency of vehicles, and encouraging use of cleaner, lower-emitting technologies and fuels. This effort is funded \$10,500 in STBG funds and RTC TDCs in lieu of cash match.

Staff is seeking Executive Board approval to spend up to \$326,000 for the purchase and placement of department education campaigns that will initiate in FY2021 during our Phase 3 approach, and of this amount approximately 70 percent is previously approved carryover funds from the FY2020 approved budget and will extend into this FY2021 education campaign plan. A draft resolution authorizing the purchase and placement of Transportation Department educational campaigns is attached for Executive Board consideration. A funding table detailing funding sources and funding amounts, including match sources and match amounts, is provided in Attachment 1 to this memorandum. I will provide a brief presentation on this item and be available to answer any questions prior to requesting Board approval.

RESOLUTION AUTHORIZING PURCHASE AND PLACEMENT OF EDUCATION CAMPAIGNS FOR TRANSPORTATION INITIATIVES: PHASE 3

WHEREAS, the North Central Texas Council of Governments (NCTCOG) is a Texas political subdivision and non-profit corporation organized and operating under Texas Local Government Code Chapter 391 as the regional planning commission for the 16-county North Central Texas region; and,

WHEREAS, NCTCOG is a voluntary association of, by and for local governments established to assist in planning for common needs, cooperating for mutual benefit, and coordinating for sound regional development; and,

WHEREAS, NCTCOG has been designated as the Metropolitan Planning Organization (MPO) for the Dallas-Fort Worth Metropolitan Area by the Governor of the State of Texas in accordance with federal law; and,

WHEREAS, the Regional Transportation Council (RTC), comprised primarily of local elected officials, is the regional transportation policy body associated with NCTCOG, and has been and continues to be a forum for cooperative decisions on transportation; and,

WHEREAS, the Dallas-Fort Worth region is in nonattainment of the federal air quality standard for ozone and NCTCOG is actively involved in the development and implementation of the State Implementation Plan for air quality; and,

WHEREAS, there has been significant regional interest to enhance coordination, communication, and awareness of various programs administered by NCTCOG; and,

On February 19, 2021, the North Central Texas Council of Governments (NCTCOG) issued a Request for Proposals (RFP) to solicit consultant assistance for the Regional Limited Access Facility (LAF) Traffic Counts and Survey Collection project which includes traffic data and travel survey data collection on limited access facilities including freeways, toll roads, and managed lanes. One firm (GRAM Traffic North Texas, Inc.) submitted a proposal in response to the RFP. The Consultant Selection Committee met on April 7, 2021, to review and evaluate the proposal. The Consultant Selection Committee recommended the GRAM Traffic North Texas, Inc. to carry out the entire project after a negotiation meeting. GRAM Traffic North Texas, Inc. is committed to a 58.3 percent Disadvantaged Business Enterprise participation goal for this project.

The 2021 Regional Limited Access Facility Traffic Counts and Survey Collection is funded through Surface Transportation Block Grant (STBG) Program funds and will utilize Regional Transportation Council Transportation Development Credits (TDC) in lieu of a cash match. The goal of the survey project is to conduct a full LAF traveler survey during 2021. The LAF includes six corridor segments selected from toll roads, managed lanes, and freeways in the region. Data collected during the survey will include trip information, fare and payment details, and socio-economic data.

A draft resolution authorizing a contract with GRAM Traffic North Texas, Inc., in an amount not to exceed \$400,000, is attached for Executive Board consideration. I will provide a brief presentation of this item and will be available to answer any questions prior to requesting Board approval.

- Item Title: Resolution Authorizing Acceptance of the FY2021 Coronavirus Emergency Supplemental Funding (CESF) Grant

The North Central Texas Council of Governments is requesting permission to accept Coronavirus Emergency Supplemental Funding (CESF) to be utilized to prevent, prepare for, and respond to the coronavirus. These funds are made available through a Congressional appropriation to the U.S. Department of Justice, Bureau of Justice Assistance. Since Regional Councils of Governments (COGs) were not eligible to apply for these funds previously, Texas expects to make approximately \$1.3 million available to COGs statewide and the North Central Texas Council of Governments is slated to receive \$238,185.92. This grant is retroactive to February 1, 2020 and closes October 31, 2021. Funds can be used to offset direct COVID-19 related costs and no matching funds are required.

Since March 2020 when Governor Abbott declared a state of disaster for all Texas counties, the North Central Texas Council of Governments (NCTCOG) has limited visitor access to our campus and a majority of staff transitioned to a remote working environment.

During this time, Emergency Preparedness staff assisted regional stakeholders with COVID-19 planning activities and coordination efforts that was not allowable to be billed to our normal funding streams. In addition to EP staffing expenses, North Central Texas 9-1-1 (NCT9-1-1) also incurred many unbudgeted expenses related to cleaning products and technology upgrades. Since all meetings during this time have been conducted via video conference, this also highlighted additional audio/visual equipment needed to upgrade our NCTCOG conference center to facilitate hybrid meeting styles needed by stakeholders.

Most of the expenses identified in the grant application have already been incurred. NCTCOG has a long history of receiving similar grant awards so we do not anticipate any issues.

A draft resolution authorizing acceptance of \$238,185.92 in FY2021 Coronavirus Emergency Supplemental Grant funds is attached for Executive Board consideration. I will provide a brief presentation on this item and be available to answer any questions prior torequesting Board approval.

Item Title: Resolution Authorizing Agreements for Senior Center Operations

The North Central Texas Council of Governments, in its capacity as the designated Area Agency on Aging (AAA), receives federal and state funding that may be used for nutrition and support services.

Currently NCTCOG has agreements with 11 county committees on aging to provide congregate meal services at senior centers. As subrecipients prepare for re-opening of the senior centers, NCTCOG wishes to fund innovative programs that will encourage older adults to attend so they may build their support networks and receive nutritious meals.

NCTCOG launched a Senior Center Operations Call for Projects in February 2021 and received six applications in response. It convened a review committee, which evaluated all proposals and recommends that four be funded.

Agreements will be awarded for a period beginning June 1, 2021 and terminating September 30, 2022, with up to two one-year extensions subject to availability of funding. Subrecipients will be reimbursed for actual expenses and subject to both program and fiscal reviews. The entities and not to exceed funding amounts for the maximum 40-month term are provided below:

- Senior Connect: \$60,000
- Somervell County Committee on Aging: \$21,000
- Erath County Senior Citizens Services, Inc.: \$25,000
- Hood County Committee on Aging: \$140,000

A draft resolution authorizing agreements with the entities and in the amounts listed above is attached for Executive Board consideration.

- Additional persons may serve as ex-officio members because of their special knowledge or experience with aging matters. These resource members may include representatives from the Veterans Administration, State Citizen Advisory Council, and the Texas Silver-Haired Legislature.

The NCTEDD is charged with the maintenance and implementation of the CEDS plan for North Central Texas and serves as the connection between the region's communities and EDA to facilitate EDA grant opportunities.

This District is organized in accordance with Federal Regulations, and its membership includes officials and/or employees of general-purpose local governments, educational institutions and private sector representatives, and they must be residents of and/or work in State Planning Region 4 – the North Central Texas Region.

As set forth in the bylaws of the District, approved by the NCTCOG Executive Board, the NCTCOG Executive Board will appoint up to 51 NCTEDD Board members, including:

- representatives from each of the 16 counties;
- 22 representatives from cities;
- 3 representatives from the private sector; and
- 10 representatives from principal economic interest (Chambers, EDCs, Post-Secondary Institutions, Workforce Development Groups, and/or Labor Groups)

Each Board member serves a term of three years and may not serve more than three consecutive three-year terms, so long as they continue to meet qualifications for the category they represent.

Item Title: Status Report - Presentation of 2021 Current Population Estimates

The North Central Texas Council of Governments (NCTCOG) has completed the 2021 Current *Population Estimates* for the North Central Texas region. This includes estimated population totals for all cities over 1,000 in population, each county, the twelve-county metropolitan planning area, and the region. Historical U.S. Census figures are also provided.

Local governments provided input as part of the estimation process and were given an opportunity to review draft numbers prior to finalization. NCTCOG's population estimates are often cited and are recognized for their coverage, timeliness, and uniqueness.

Brian Lister, Senior Research Data Analyst, will be available at the Executive Board meeting to present the 2021 Current Population Estimates and to review the highlights of the region's population growth during the past year.



REGIONAL OCCUPANCY RATE CHANGE







Summary

The estimated January 1, 2021 population for the NCTCOG region is 7,874,950. Last year the region added 158,540 people. Even though the north central Texas region, as well as the rest of the country faced a big challenge due to the pandemic, the region still managed to grow by almost the same amount as it did in 2019. In 2020, 12 cities grew by 10% or more. Fort Worth led the region in growth, adding almost 17,000 people last year while Frisco added close to 16,000, followed by McKinney with 6,100 and Dallas with 5,560. Collin, Denton, Dallas, and Tarrant Counties each added more than 25,000 people last year, with Collin County leading the way with 43,000 new residents. The region has added more than 1.3 million new residents since 2010.





2021 Population Estimates Methodology

NCTCOG uses the housing unit method for estimating current year population:

Estimated household population = estimated units * estimated occupancy rate * estimated persons per occupied unit

The calculation is performed for each unit type (single family, multi-family, other). The results are summed along with an estimate of group quarters population to arrive at a total population estimate. Every year, cities are asked to provide information about changes in housing stock and population in group quarters housing. Cities are also given the opportunity to review figures prior to release. Heath and West Tawakoni did not participate in the survey. The 2020 population estimates for some cities have been revised. The estimates included herein supersede any prior estimates.

Various totals and percentages provided throughout this report are calculated on rounded figures and therefore might not match precise sums and percentages calculated on unrounded figures.
