DISCUSSION

- 2. Discussion of the 2018 International Fire Code and the 2018 Regional Amendments.** The Board will review the International Fire Code Regional Amendments and other items related to the code review as deemed necessary.

The Advisory Board discussed changes made to the 2018 IFC from 2015 and discussed any major edits that may need amendments. The board discussed the major changes from the 2015 to 2018 IFC as identified through individual reviews of IFC chapters. The International Fire Code chapters reviewed at this meeting include: 12, 22, 23, 27, 28, 31, 32, 33, 38, 39, 53, 56 and 57. An overview of each chapter was given by the individual who conducted the initial review. There were no major edits made to these aforementioned chapters. The majority of edits made were changes to the verbiage from the 2015 IFC amendments and updating the section numbers to match the 2018 code. However, Chapter 31 section 3103.1 was deleted from the amendments.

The board will review/discuss the International Wildland Urban Interface Code and take a vote on the outstanding amendments during the next meeting.

- 4. Roundtable Topics/Other Business.** FAB members and NCTCOG may share additional items of interest as time allows.

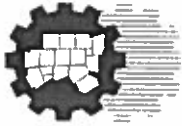
