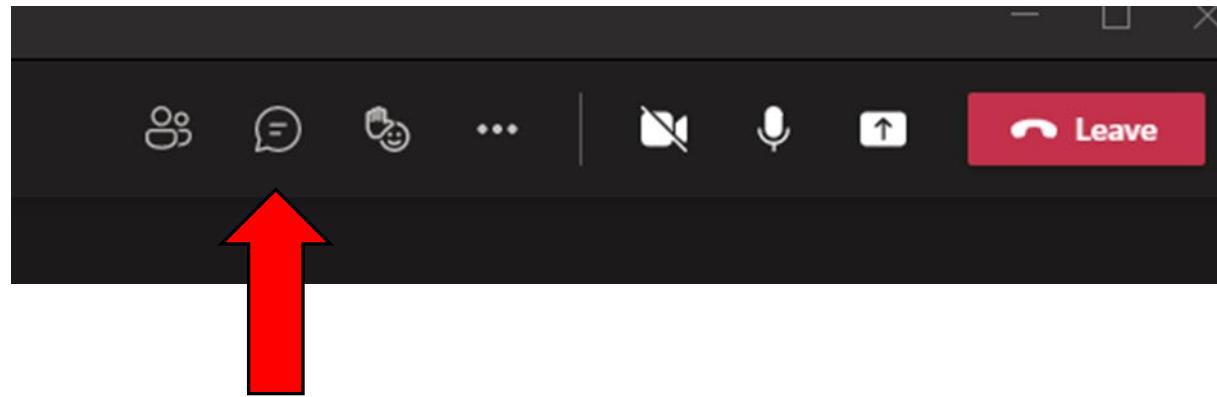

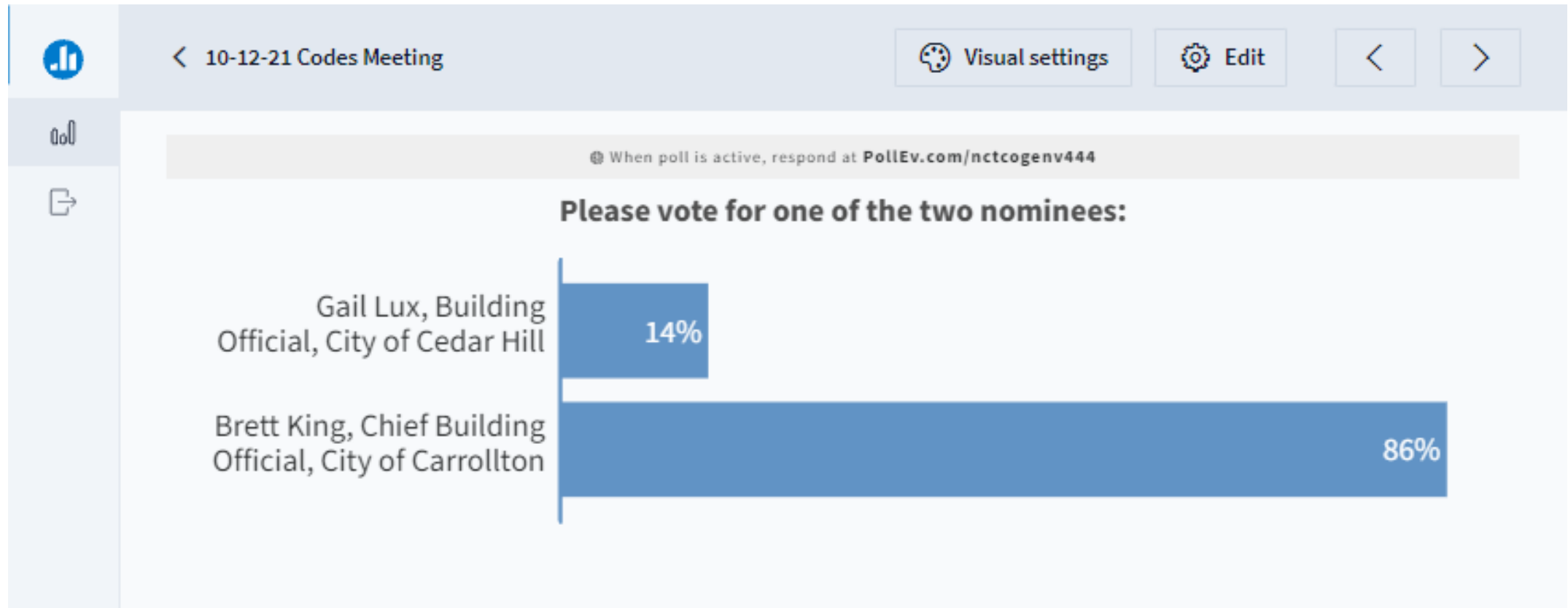

RCCC Solar-Ready Provisions Support Statement.** Staff has developed a Support Statement outlining a recommended amendment to the Solar-Ready Provisions (2021 IECC [Appendix RB](#) and 2021 IRC [Appendix AT](#)). This Support Statement and amendment were developed with input from the Energy and Green Advisory Board (EGAB). EGAB reviewed the appendices. The Fire Advisory Board (FAB) and the Building and Residential Advisory Board (BRAB) have commented on the Support Statement at the request of the EGAB.
