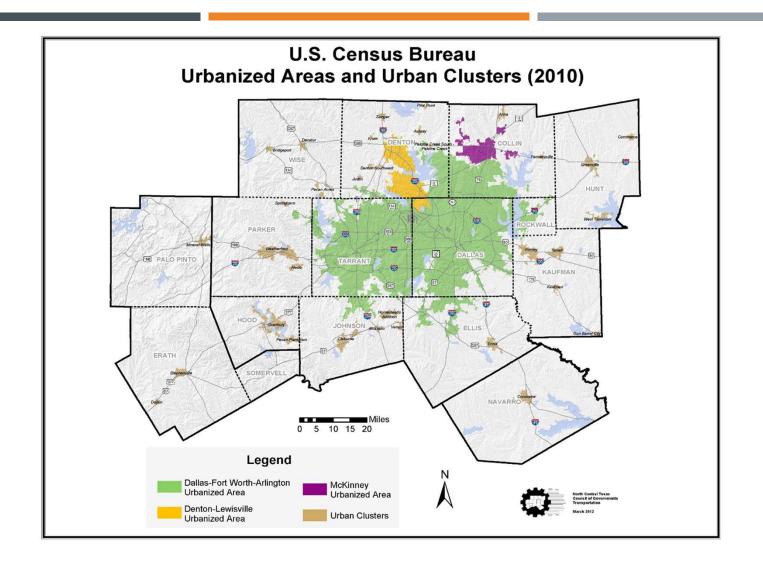

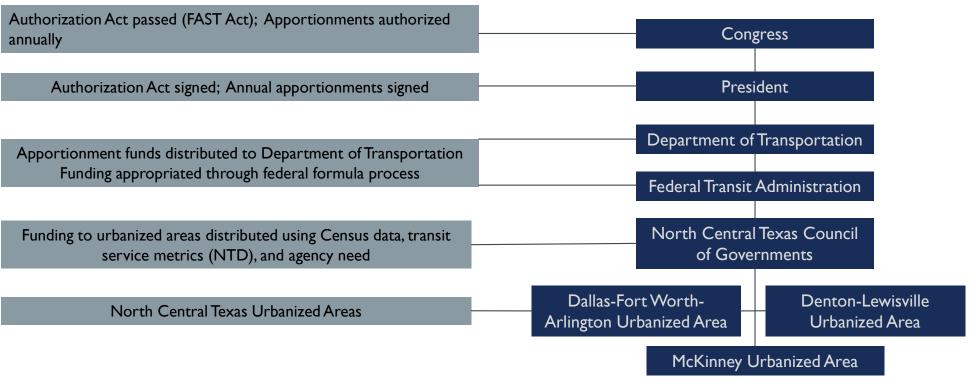
2021 APPORTIONMENT FUNDING AND PROGRAM OF PROJECTS DEVELOPMENT

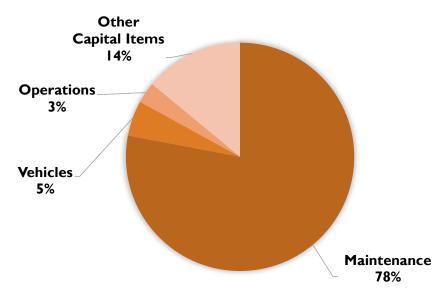

PROGRAM OF PROJECTS (POP) DEVELOPMENT

- What is POP Development?
 - Process by which NCTCOG works with traditional transit providers to determine funding needs based on current funding levels and expenditures
 - Traditional Transit Providers agencies providing public transportation services and recognized by the state as rural or urban transit providers
 - NCTCOG staff review funding requests and work with providers to accommodate those requests within the confines of the current year apportionment in accordance with applicable regulations
- Per NCTCOG's Regional Transportation Council policy, small provider needs will continue to be met first, with the transit authorities receiving the remainder of the funds
- Awarded funding will be communicated through the Split Letter sent out by NCTCOG
 - Split Letter notifies FTA of the allocation of formula funds

KEYS TO POP DEVELOPMENT

Only expenses attributable to the urbanized area are eligible

Funding requests should account for the public health emergency

Single Split Letter Process

Subrecipients: Requests should account for capital expenditures through March 2023

Subrecipients: List of anticipated procurements will need to be submitted before award if requesting funding for project administration and capital projects

Subrecipients: Procurement timelines, 3-5 year Capital Improvement Plans, Cost Allocation Plans, and Architectural statements for Intelligent Transportation Systems projects

KEYSTO FORMULA FUNDS

- Focus on <u>National Transit Database</u> reporting
 - More service provided and reported in the urbanized area = More <u>urban funds</u> for the region
- Plan ahead on how formula funds will be used for urban services
 - Ensure financial resources are proportionate to the federal funding requested
 - Ensure a local match is in place for the federal funding requested
- NCTCOG requirements to continue receiving formula funds
 - Work with your Project Managers to develop your Program of Projects
 - Submission of annual audits
 - Adequate financial controls carried out by qualified personnel with checks and balances in place
- FTA requirements must be met to continue receiving formula funds
 - FTA's Certifications and Assurances
 - Direct recipients can reach out to their FTA contact for further information

PROCUREMENT ACQUISITION THRESHOLDS

- Micro-Purchases revised from \$3,500 to \$10,000
- Simple Acquisition Threshold from \$150,000 to \$250,000
- Applies to all FTA-funded procurements, unless agency must follow a lower threshold in State law
 - Texas State law thresholds (applicable to Municipalities and Councils of Governments):
 - Micro-Purchase \$3,000
 - Simple Acquisition \$50,000
- All policies and procedures related to procurements need to be revised to reflect changes
 - If updates aren't complete, must be adhering to strictest thresholds currently documented

TOP FIVE PROCUREMENT & CONTRACT COMPLIANCE CONCERNS

- Incomplete Independent Cost Estimate
- Missing Required FTA and Federal Clauses
- Missing or Incomplete Price Analysis
- Lacking Appropriate Compliance Checks (e.g., Organizational Conflicts of Interest,
 Debarment)
- Missing or Inadequate Sole Source Justification

INDEPENDENT COST ESTIMATE (ICE)

- Purpose of ICE: Done before solicitation to determine estimation of what the item or service "should" cost.
- Different Methodologies for ICE:
 - Historical pricing information from previous contracts awarded
 - Utilize appropriate inflation rate to bring to current consumer price index
 - Comparable purchases by other agencies
 - Utilize contract award amount versus independent cost estimate for project
 - Independent third-party estimates
- Only use <u>one</u> methodology as an element for ICE.
- Provide sufficient documentation to clarify any "grey" areas and to add as much detail about the methodology as possible.
- Ensure comparison is of similar data and information.

REQUIRED FTA AND FEDERAL CLAUSES

- Ensure FTA required clauses are included in Solicitation & Contract with Awarded Contractor
 - Utilize the Contract Clause Matrix to Determine FTA Required Clauses (FTA C 4220.1F, Appendix D-4)
- If ICE or Contract is within \$10,000 of threshold, recommend adding in required clauses above the threshold
 - Ex: ICE is \$20,000 recommend including Debarment & Suspension which is required for contracts greater than \$25,000
- Ensure required provisions under 2 Code of Federal Regulations 200 (2 CFR 200) are included in Solicitation & Contract Award

PROHIBITION ON CHINESE TELECOMMUNICATIONS

- Prohibits the use of federal funds to procure, contract with entities who use, or extend contracts with entities who use certain telecommunications and video surveillance equipment provided by Chinese controlled entities (2 CFR §200.216, §200.471).
- Effective August 13, 2020
- Recommend adding language to solicitations, subrecipients agreements, contracts, and purchase orders.
 - For subrecipient agreements and contracts, also recommend including a certification statement.

PRICE ANALYSIS

- Price Analysis is used to determine the reasonableness of prices once bids have been received.
- Price Analysis should be compared to the ICE completed before solicitation (both should be completed for every procurement).
- 6 Methodologies for acceptable Price Analyses:
 - Adequate price competition
 - At least two offerors respond to solicitation & satisfies the requirements
 - Each offeror must submit priced offers responsive to the expressed requirements of solicitation
 - Prices set by law or regulation
 - Acquire a copy of the rate schedules, verify they apply to your situation, and that you are charged the correct price
 - Established catalog prices and market prices
 - Dependent on if catalog prices exist, the items are commercial in nature, sold in substantial quantities, and are sold to general public
 - Comparison to previous purchases
 - Comparison to a valid Grantee independent estimate
 - Have the estimator give you method and data used in developing estimate
 - Value analysis
 - look at the item and the function it performs so its worth can be determined

COMPLIANCE CHECKS

- A Conflict of Interest means no employee, officer, agent, board member, or immediate family member, partner, or
 organization that employs or is about to employ the parties may participate in the selection, award, or administration of
 a contract supported by FTA funding.
- Organizational Conflict of Interest should be evaluated at the time of solicitation.
 - If acquiring quotes, then review of potential conflicts should be completed prior upon award and prior to issuance of a purchase order.
- The overarching question for Conflict of Interests:
 - Does anyone inside of your agency have a conflict of interest before awarding your contract?
- The Conflict-of-Interest Questionnaire can be used to review and evaluate potential conflicts.
- Debarment & Suspension checks through <u>www.sam.gov</u> confirms a potential Contractor has not been debarred or doesn't have another active exclusion.
 - Should be evaluated prior to contract award and prior to amendments or is recommended to be reviewed prior to amendments and change orders.

SOLE SOURCE PROCUREMENTS

- All sole source procurements require NCTCOG's pre-approval.
 - New procurements
 - Annual License Renewals
 - Request for Proposals resulting in one bid
- Sole Source Procurements require completion of an ICE
- Sole Source Procurements require specific justification and documentation
- If submitted in an invoice without pre-approval, invoice may be returned unpaid while documentation is reviewed and approved
- If pre-approval isn't received, sole source procurement may not be eligible or approved for reimbursement

DBE GOALS

- FTA Subrecipient DBE Goals:
 - Building Construction 29.7%
 - Marketing, Advertising and Public Relations Services <u>5.7%</u>
 - Includes specialty print services, printing and postage costs, sign manufacturing, and advertising agency support
 - Office Supplies and Equipment (Rental & Purchases) 1.0%
 - Operational Administrative, Communications, and Support Services 4.9%
 - Includes insurance, uniforms, security, janitorial, landscaping, pest control services, communication services, audit services, building maintenance, training, and specialty trade contractors for general operations support
 - Planning and Engineering <u>26.7%</u>
 - Software and Ancillary Information Technology Professional Services <u>1.6%</u>
 - Vehicle Maintenance and Operations Support <u>1.2%</u>
 - Includes tires, engine oils, fluids, stock parts, stock supplies, shop tools for preventative maintenance, vehicle graphics, towing, fuel, and preventative maintenance
- Weighted by Contract Award 3.2%

COVID-19 Relief Funding Update

Coronavirus Aid, Relief, and Economic Security (CARES) Act

- Signed into Law March 27th, 2020
- Funding provided at 100-percent federal share, with no local match required
 - Available for capital, operating, and other expenses generally eligible under Section
 5307 to prevent, prepare for, and respond to COVID-19
 - Expenses incurred on or after January 20, 2020 are eligible for reimbursement
- Funding not required to be included in the Transportation Improvement Program unless project involves a substantial change to the location, function, or capacity of an asset

Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA)

- Signed into Law December 27, 2020
- Prioritized operations and payroll needs
- CRRSAA allocated \$50M for Section 5310 public transportation providers
 - Projects must be included or consistent with the coordinated public transithuman services transportation plan (Access North Texas)

American Rescue Plan Act

Bill passed by the Senate on Saturday, March 6th

Section 5307

- Following previous COVID relief bills, funding will be provided to prevent, prepare for, and respond to the coronavirus public health emergency
- Urbanized areas set to receive an amount equal to 132 percent of the urbanized area's 2018 operating costs when combined with amounts from the CARES Act and CRRSAA

Section 5310

 Amounts to be made available under this bill would be allocated to urbanized areas in the same ratio as funds provided under Section 5310 for Fiscal Year 2020

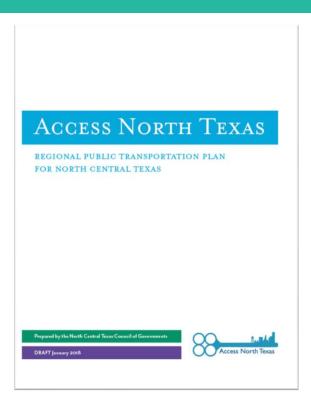
